



RECS Market Meeting Website Terms and Conditions

These Terms & Conditions (“Terms”) govern your access to and use of the website www.recmarket.eu, operated by **RECS Energy Certificate Association** (RECS). By accessing or using the website, you agree to be bound by these Terms, in addition to any other policies referred to herein (e.g. Privacy Policy). If you do not agree to these Terms, do not access or use the Site.

1. Definitions

- **“Website”** means www.recmarket.eu and all of its associated subdomains, content, services, and features.
- **“We”, “us”, “our”** refers to RECS Energy Certificate Association, the operator of the Website.
- **“You”, “your”** means any user of the Website.
- **“Conference / Event”** means the REC Market Meeting and/or any associated meetings, sessions, workshops, or events promoted via the Website.
- **“Registrant / Delegate”** means a person who has registered to attend the Conference.

2. Use of the Website

- You may use the Website for lawful purposes only. You must not use it in any manner that is unlawful or that infringes the rights of any third party.
- You must not upload or transmit through the Site any material which is defamatory, obscene, infringing, or otherwise objectionable.
- You agree not to use the Website in any way that could disable, overburden, damage, or impair the site, or interfere with any other user’s access.



3. Registration, Payment & Access to the Conference

- Registration to attend the Conference is via the Website, according to the registration options published.
- Payment methods, pricing, and what is included in the registration fee (sessions, meals, access to app, etc.) will be as specified on the Website.
- Confirmation of registration will be sent by e-mail. Access to certain features of the Conference (including entrance to the venue, sessions, etc.) may be conditional upon payment being completed in full.
- Ticket Terms and Conditions will be made available on the registration page of the Website in advance of the registration opening for the event.

4. Intellectual Property

- All intellectual property rights on the Website and its content (text, graphics, logos, images, software, audio and video clips, data compilations) are owned by or licensed to RECS unless otherwise stated.
- You may view, download for caching purposes, and print pages from the website for your own personal, non-commercial use, subject to the restrictions set out in these Terms.
- You must not reproduce, republish, distribute, transmit, modify, adapt, or create derivative works of the content except as expressly permitted in writing by us.

5. Privacy & Data Protection

- Your use of personal data is governed by the Privacy Policy.
- By registering, you consent to the collection, use, and processing of your personal data for the purposes of managing your registration, communications, and for promotional and networking purposes related to the Conference.
- Photos, videos, and recordings may be taken during the Conference. By attending, you consent to the use of your image and voice in such media for



marketing or documentation purposes, unless you notify us in advance that you object.

6. Limitation of Liability

- To the fullest extent permitted by law, RECS shall not be liable for any damages arising from your use of the Website or your participation in the Conference, including any indirect or consequential losses.
- In particular, RECS is not responsible for any losses, costs or expenses you may incur if you are unable to attend due to travel restrictions, visa issues, illness, or other circumstances beyond your control.

7. Governing Law & Dispute Resolution

- These Terms are governed by the laws of the Netherlands (or the country in which RECS is incorporated).
- Any dispute arising out of or in connection with these Terms shall be submitted to the competent courts in **'s-Hertogenbosch, Netherlands**, unless otherwise required by applicable law.

8. Miscellaneous

- These Terms (together with the Privacy Policy and any other policies) constitute the entire agreement between you and us regarding your use of the Website and the Conference, superseding any prior agreements.
- If any part of these Terms is found invalid or unenforceable, that part shall be severable, and the remainder of the Terms shall remain in full force and effect.
- We may update or amend these Terms from time to time. The version posted on the Website at any given time is the version in force. Continued use of the Website or attendance to the Conference after changes have been posted constitutes your acceptance of the changes.
